#### **Potential Health Effects**

Eye Contact: Essentially nonirritating to eyes. Corneal injury is unlikely.

Skin Contact: Prolonged contact may cause slight skin irritation with local redness.

**Skin Absorption:** Prolonged skin contact is unlikely to result in absorption of harmful amounts. **Inhalation:** At room temperature, exposure to vapor is minimal due to low volatility. Prolonged

exposure to aerosol/mist may cause serious adverse effects, even death.

**Ingestion:** Very low toxicity if swallowed. Harmful effects not anticipated from swallowing small

amounts.

## First-aid measures

**Eye Contact:** Flush eyes thoroughly with water for several minutes. Remove contact lenses after the initial 1-2 minutes and continue flushing for several additional minutes. If effects occur, consult a physician, preferably an ophthalmologist.

Skin Contact: Wash skin with plenty of water.

**Inhalation:** Move person to fresh air. If not breathing, give artificial respiration; if by mouth to mouth use rescuer protection (pocket mask, etc). If breathing is difficult, oxygen should be administered by qualified personnel. Call a physician or transport to a medical facility.

**Ingestion:** No emergency medical treatment necessary.

**Notes to Physician:** Maintain adequate ventilation and oxygenation of the patient. Exposure to high concentrations of mist/aerosol may be associated with delayed lung damage. No specific antidote. Treatment of exposure should be directed at the control of symptoms and the clinical condition of the patient.

**Medical Conditions Aggravated by Exposure:** Repeated excessive exposure may aggravate preexisting lung disease.

# 5. Fire Fighting Measures

**Extinguishing Media:** Water fog or fine spray. Dry chemical fire extinguishers. Carbon dioxide fire extinguishers. Foam. Do not use direct water stream. May spread fire. Alcohol resistant foams (ATC type) are preferred. General purpose synthetic foams (including AFFF) or protein foams may function, but will be less effective.

Fire Fighting Procedures: Keep people away. Isolate fire and deny unnecessary entry. Use water spray to cool fire exposed containers and fire affected zone until fire is out and danger of reignition has passed. Fight fire from protected location or safe distance. Consider the use of unmanned hose holders or monitor nozzles. Immediately withdraw all personnel from the area in case of rising sound from venting safety device or discoloration of the container. Burning liquids may be extinguished by dilution with water. Do not use direct water stream. May spread fire. Move container from fire area if this is possible without hazard. Burning liquids may be moved by flushing with water to protect personnel and minimize property damage.

**Special Protective Equipment for Firefighters:** Wear positive-pressure self-contained breathing apparatus (SCBA) and protective fire fighting clothing (includes fire fighting helmet, coat, trousers, boots, and gloves). If protective equipment is not available or not used, fight fire from a protected location or safe distance.

**Unusual Fire and Explosion Hazards:** Container may rupture from gas generation in a fire situation. Violent steam generation or eruption may occur upon application of direct water stream to hot liquids. **Hazardous Combustion Products:** During a fire, smoke may contain the original material in addition to combustion products of varying composition which may be toxic and/or irritating. Combustion products may include and are not limited to: Carbon monoxide. Carbon dioxide.

#### Handling

#### **Storage**

Store in the following material(s): 316 stainless steel. Carbon steel. Glass-lined container. Polypropylene. Polyethylene-lined container. Stainless steel. Teflon. This material may soften and lift certain paint and surface coatings. Use product promptly after opening. Store in original unopened container.
